ORDER

As per circulars read above, necessary directions were issued to State owned Public Sector Undertakings, Co-operative Institutions and Universities regarding the compulsory Insurance of assets/properties of these institutions through the Kerala State Insurance Department. At present, it has come to the notice of the Government that the above mentioned institutions are not adhered to these instructions.

Government after having examined the matter in detail are pleased to issue the following orders with immediate effect:-

- I. All the General Insurance transactions of the Public Sector Undertakings and Universities shall be carried out only through Kerala State Insurance Department.
- II. The entire General Insurance business of Co-operative Institutions in the State including Co-operative Banks shall be done through Kerala State Insurance Department. Any Order/Circular in violation of the above instructions issued by the Registrar of Co-operative Societies shall be withdrawn immediately as directed by Government, earlier.
- III. The Heads of Office/Chief Executives of the above Institution shall render all necessary assistance and co-operation to the Development Officers of Kerala State Insurance Department for the smooth functioning of General Insurance Business.

IV. The Chief Executives/Heads of Office/Office bearers of Co-operative Institutions shall urgently intimate the details of their present Insurance Business such as the name of the Present Insurance Company, Premium details of insured assets etc, to District Insurance Officer/Director of Insurance, Kerala State Insurance Department.


Any deviation/omission on the part of Public Sector Undertakings, Universities and Co-operative Institutions adhering to the above orders will be viewed seriously by Government,
