As per Government order read above, State Government have stopped enrolling of teaching and non-teaching staff of the Private Aided Schools/Colleges/Polytechnics to the Group Insurance Scheme with effect from 1-11-2001 onwards. The authorities and employees organisation of these bodies have approached Government with the request for extension of the scheme to them.

The Director of Insurance vide letter read 2nd above have also requested to issue orders extending SLI and Group Insurance Scheme to the employees of Aided Schools/Colleges/Universities, Public Sector Undertakings and other Semi-Government bodies.

Government have examined the matter in detail and are pleased to accord sanction to extend the Group Insurance Scheme to the staff of Aided Schools/Private Colleges, Universities, Public Sector Undertakings and other Semi-Government bodies.
