Abstract

Group Personal Accident Insurance Scheme – Modification - Orders issued.

ORDER

1) As per Government order read above, Government have implemented Group Personal Accident Insurance Scheme to employees of Government Institutions through Kerala State Insurance Department. Accordingly who met with an accident would get a compensation of Rs. 8 lakh.

2) Para 11 (b) (c) of the G.O under reference, the guidelines for claiming benefit in such circumstances / cases by Nominees/dependents / client as the case may be. The large number of cases are pending in various offices / Kerala State Insurance Department as the time stipulated run in with traditions / customs and trumas of separation and hence nominees fail to submit claims within the time line. The affected parties and IRDA have approached Govt. with request to dispense with time line and clear their claim held up due to that in department invoking para 12 (d) of G.O under reference.

3) On examination Govt. found substance in the argument. Accordingly the para 11 (b) (c), para 12 (a) and para 5 stand modified to the following effect.

4) The nominee / dependent / client would take up the case with District Insurance Officer where the employee worked last, within 3 months of the accident, with duly filled check list appended with the G.O. (Reproduction of para 11 (d) (e) of G.O dated 23.11.2010). He would forward the claim within 15 days adding a brief note of incident to Director of Insurance and Director of Insurance will dispose the case within 2 months after it received in his office. In short, in normal case, a case of GPAIS will be settled within a maximum period of 5½ month since the accident occurred. Those who happened to be under treatment due to accident he (she)/nominee /


dependent can take claim within 30 days after discharging from the hospital and proof thereof will be provided with claim. All pending but deserving cases may be settled invoking instructions in para 4 ibid forthwith.
